

**PERMISSION FORM FOR PARTICIPATING IN EAST CHAMBERS
JUNIOR HIGH DANCE TEAM**

Note: In order to be eligible for tryouts, all forms must be submitted on or before 2/16/2012

I _____ (parent or guardian), agree to

allow my child, _____ (child's name) to be a candidate for dance team membership at East Chambers Junior High. I understand the voluntary nature of the program and the activities that will be required of my child. I have read the rules and regulations and understand that my child must be present for all games and attend all practices and tryout sessions; failure to attend all such activities may result in my child being ineligible for a drill team position. I further understand that any violations of the rules or regulations may result in temporary or permanent suspension from the squad.

I understand that while student safety and well-being are priorities for ECISD, the District is not responsible for medical costs or other personal expenses associated with my child's participation in the program. I also understand that by participating in the program, my child may be subject to such risks.

I understand that ECISD, its Trustees, employees, and agents are not waiving any sovereign or governmental immunity, which it or they have under Texas law.

I hereby expressly waive all claims for medical expenses, loss of services, or other claims, and I agree to hold harmless the District, its Trustees, employees, and agents from all claims made by third parties against it or them which result from my child's actions while participating in drill team activities.

I understand that my son/daughter will be evaluated by qualified judges and agree to respect the decisions of the judges.

I understand there may be some cost related to participating in this activity, which may be my responsibility. I agree to allow my child to participate in

all fund raisers to help pay for items the school does not purchase for the students. I will also help or provide a helper to aide in fundraisers for our extra activities we do during the year. The school will provide all uniforms, camp costs, and meal money for away games. All non-purchased items must be turned in at the end of the season or reimbursed if damaged or lost.

Tryout practices will be held in the Junior High gym on Tuesday, February 21st from 4:30- 7:00 and on Thursday, February 23th from 4:30- 7:00. Wednesday's practice will be held from 4:30 to 6:00. Tryouts will be held on Friday, February 24th beginning at 4:00pm. Tryout session is closed to the public. Once a participant has tried out, then she is immediately released to go. The results will be posted on the website.

I understand that a physical will be required before dance team camp, either by a private doctor or by utilizing the school provided physical.
